There are two sub-committees of the Governing body - the Finance and Resources Committee, and the Curriculum and Staffing Committee.

There is a meeting of the Full Governing Body each $\frac{1}{2}$ term. The Finance and Resources Committee also meet $\frac{1}{2}$ Termly. The Curriculum & Staffing Committee meet termly.
